This Vendor Agreement is made by and between the undersigned vendor and the Saint Andrews Chamber of Commerce for the limited right to use an allocated space in the Saint Andrews Market Square for the sale of goods at the Christmas Night Market.

The Vendor agrees as follows:

- 1. Rules of Operation.** Vendor has received a copy of the Market Rules of Operation (the "Rules") and hereby agrees to comply with the Rules.
- 2. "As Is" Condition.** Vendor agrees to use the Space in its "as is" condition
- 3. Allowed Goods.** Vendor will use the Space solely for the purposes of the Market to sell arts/crafts, seasonal decor, fresh fruits, vegetables, flowers, sauces, meats, cheeses, other food products and/or ancillary items. The Space shall not be used for any other purposes without the consent of the Chamber of Commerce Manager.
- 4. Set-Up by 4:00 p.m. on each Market Day** or days which have been previously agreed on by the Vendor and the Chamber of Commerce. Vendor shall only erect stands for the purpose of selling goods. **By 10:00 p.m. on each Market Day,** Vendor shall cause its stands to be disassembled and its Space to be cleaned of debris. Vendor shall ensure Space to be restored to the condition it was in before the Market Day.

5. **The Vendor shall comply with all Township ordinances, resolutions, rules, and regulations.** A copy of these Township ordinances, resolutions, rules, and regulations are available at the Township Building.

6. **Electrical supply is not available from the Township**

7. **No sound equipment is permitted without the Township Manager's prior written approval**

8. **Refuse. The Town of Saint Andrews** will supply barricades and garbage cans for use in the market area.

9. **Insurance.** Prior to the first Market Day, The Vendor shall procure and maintain adequate insurance coverage of at least \$50,000 for bodily injury for each person and at least \$100,000 for property damage per occurrence to protect it from claims for damages which may arise both out of and during the operation under this Agreement.

10. **Indemnification.** Vendor shall indemnify, defend, and hold and save the Saint Andrews Chamber of Commerce and Town of Saint Andrews, and their respective officers, directors, agents and employees, harmless from any and all claims, suits, demands, debts, undertakings or proceedings of any kind or nature, arising out of the Vendor's use of the Space.

By signing this Agreement, the Vendor understands and accepts all the terms and conditions stated and/or incorporated herein.

The Vendor understands that the St. Andrews Chamber of Commerce reserves the right to terminate this Agreement at any time, for any reason. The Vendor understands that the failure by it, or its employees or agents to follow any of the above terms and conditions of this Agreement will result in the forfeiture of any fees or deposits paid and possible denial of any future requests, applications, or permits from the Township.
